Description

Sovereign M8 Woodworm Concentrate is supplied as a 250ml concentrate requiring dilution with water to form a ready to use product. The formulation is based on micro emulsion technology to achieve the desired effect in a non solvent and VOC free based system. Its active ingredient is designed to give the maximum spectrum of biological activity against a wide range of wood boring insects (specifically woodworm) including their larvae. It provides rapid absorption into the timber giving high levels of penetration. It has virtually no odour and can be applied either by brush or low pressure spray to give long lasting protection.

Properties

Sovereign M8 Woodworm Concentrate contains the synthetic pyrethroid insecticide Permethrin. This insecticide is effective against all life stages of wood boring insects whilst the surfactant system used in the formulation promotes rapid absorption and deep penetration into timber.

Sovereign M8 Woodworm Concentrate has a HSE statutory 1-hour re-entry time.

Sovereign M8 Woodworm Concentrate is cleared under the Governments Pesticide Safety Precaution scheme and under the Control of Pesticide Regulations 1986. HSE 10683

Preparation

Timbers to be treated must be clean and sound and the source of any dampness permanently cured. Timber must be bare, with all surface coating's such as paint and varnish removed. Dust should also be removed, preferably by vacuuming. Cut back severely damaged timber back to sound wood.

DILUTION

Sovereign M8 Woodworme concentrate must be diluted prior to use. A 250 ml bottle should be diluted with water to make 25 litres of ready to use solution. For best results the concentrate and water should be at room temperature. For both mixing and application the minimum temperature is 5°C.

USAGE

The product can be applied by brush or spray. When spraying use a low pressure, non-atomising pesticide sprayer. Ensure the correct coverage is achieved, as application of insufficient material may not prevent future attacks. The best way to achieve the correct coverage is to make an estimate of the TOTAL SURFACE AREA to be treated. The required quantity of diluted product should then be made to treat this area, which may take two applications depending on the porosity of the timber. When multiple applications are required to achieve the correct coverage then a drying time of 30 minutes between coats should be allowed.

DRYING

Sovereign M8 Woodworm Concentrate should be touch dry in 1 hour depending on wood and ambient conditions. Unprotected persons and animals should be kept away from treated areas and surfaces until dry.

FINISHES

Sovereign M8 Woodworm Concentrate does not affect the look of the timbers although will leave a wet look until dry. Sovereign M8 Woodworm Concentrate should be suitable for over coating 24 hours after application depending on wood and ambient conditions.

GENERAL

Untreated timber should not be allowed to become damp. For long-term protection treated timber should not be subject to prolonged wetting.

CLEAN UP

All equipment may be cleaned with water. A full safety data sheet is available on request.

COVERAGE

Application rate for 1 L of diluted product is 3 - 4 m².

Storage: Between 5°C - 30°C.

Shelf Life: 24 months when stored as directed.
