Technical Specification

1 Description

- 1.1 ProBead External Render Beads are PVC-U extrusions designed for use with render in external applications. The back plates incorporate oval holes and a ribbed surface, providing a key for the render.
- 1.2 The available types are:




Figure 1 Standard bellcast beads (all dimensions in mm)

- Standard bellcast beads (3BC10, 3BC15 and 3BC20) for forming a reinforced stop (or bellcasting) at the lower edge of external rendering (see Figure 1)






Figure 2 Wide bellcast beads (all dimensions in mm)


Figure 3 Standard stop beads (all dimensions in mm)

- 1.3 The products are available in the following colours:

- 1.4 The products meet the dimensional specifications given for angle beads, stop beads and render stop beads in accordance with BS EN 13658-2:2005.
- 1.5 The products have pre-drilled, 2 mm diameter holes at 68 mm centres along their length for fixing, where required.
- 1.6 The products are supplied in 3 m lengths.

2 Manufacture

- 2.1 The profiles are extruded from recycled PVC-U.
- 2.2 As part of the assessment and ongoing surveillance of product quality, the BBA has:
- agreed with the manufacturer the quality control procedures and product testing to be undertaken
- assessed and agreed the quality control operated over batches of incoming materials
- monitored the production process and verified that it is in accordance with the documented process
- evaluated the process for management of nonconformities
- checked that equipment has been properly tested and calibrated
- undertaken to carry out the above measures on a regular basis through a surveillance process, to verify that the specifications and quality control operated by the manufacturer are being maintained.

3 Delivery and site handling

- 3.1 ProBead External Render Beads are delivered in packs of one type, each containing 34 by 3 m beads. Each pack is labelled with the Certificate holder's name, product code and the BBA logo incorporating the number of this Certificate.
- 3.2 Packs of profiles should be stored flat, away from direct sunlight and excess heat, and supported along their length to prevent distortion.

Assessment and Technical Investigations

The following is a summary of the assessment and technical investigations carried out on ProBead External Render Beads.

4 Use

- 4.1 ProBead External Render Beads are for use with external rendering on walls of masonry or dense concrete construction.
- 4.2 The products are suitable for use in the situations given in Table 1.

5 Practicability of installation

The products are designed to be installed by a competent general builder experienced in external rendering.

6 Structural stability

- 6.1 The products provide adequate fixing and support to the applied render.
- 6.2 The profiles have adequate resistance to mechanical damage, but can be damaged by severe impacts.

7 Properties in relation to fire



7.1 The products have not been classified in accordance with BS EN 13501-1: 2018.



7.2 In England and Wales, the products should not be used on buildings with a storey at least 18 m above ground level and which contain one or more dwellings, an institution, a room for residential purposes (excluding any room in a hostel, hotel or boarding house), student accommodation, care homes, sheltered housing, hospitals or dormitories in boarding schools.



7.3 In Scotland, the products should not be used with buildings with a storey more than 11 m above the ground, or on any entertainment or assembly building with a total storey area more than 500 m^2 , or on any hospital or residential care building with a total storey area more than 200 m^2 .

7.4 Designers should refer to the relevant national Building Regulations and guidance for detailed conditions of use, particularly in respect of requirements for substrate fire performance, cavity closers and barriers, fire stopping of service penetrations and combustibility limitations for other materials and components used in the overall wall construction.

8 Maintenance

As the products are used in a wall structure and have suitable durability (see section 9), maintenance is not required.

9 Durability



9.1 The products are formed from durable materials and will perform adequately as a support for external rendering for a period of at least 25 years.

9.2 There will be some loss of colour over this period. This will vary depending on the colour chosen, but will not be excessive and will be consistent over any one aspect face.

Installation

10 Procedure

- 10.1 The correct size of profile should be selected for the particular application (see Table 1) and cut to length using normal hand tools, such as a fine-toothed saw.
- 10.2 The products are fixed to the wall with corrosion-resistant fixings, using the pre-drilled holes provided, and/or by bedding into render previously applied to the substrate. Galvanized steel fixings can be used, in accordance with BS EN 13914-1: 2016, but stainless steel should be used in corrosive or coastal locations (less than 5 km from the sea).
- 10.3 Render is subsequently applied over the beads in a conventional manner, ensuring that it is fully compacted and placed to the edge of the nosing.
- 10.4 The external rendering must be applied in accordance with BS EN 13914-1: 2016 and the render manufacturer's instructions.

Technical Investigations

11 Tests

Tests were carried out to determine:

- ash content
- tensile strength and elongation
- impact resistance
- dehydrochlorination
- heat ageing characteristics
- · thermal shrinkage

- · resistance to artificial weathering
- pull-out resistance of fixings
- pull-out resistance from render.

12 Investigations

- 12.1 The manufacturing process was evaluated, including the methods adopted for quality control, and details were obtained of the quality and composition of the materials used.
- 12.2 A postal user survey was carried out to assess the products' performance in use.
- 12.3 Visits were made to sites where the products had been in service for up to five years.
