- 1. UNLESS OTHERWISE STATED, PRICES QUOTED ARE FOR TANKS TO STORE COLD WATER ONLY UP TO 40°C CONSTANT.
- 2. GRADE B (FEED/EXPANSION TANKS) ARE FOR STORING WATER AT 70°C CONSTANT.
- 3. GRADE A TANKS ARE FOR STORING CHEMICALS AND WATER UP TO 100°C CONSTANT.
- 4. UNLESS SPECIFIED ON THE QUOTE TANKS ARE SUPPLIED WITHOUT INSULATION. IF INSULATION IS REQUESTED IT CAN BE SUPPLIED IN 25MM, 50MM, 75MM AND 100MM. 25MM IS STANDARD AND IS THE SIZE OUOTED UNLESS OTHERWISE STATED.
- 5. WITH ALL PRE INSULATED TANKS STANDARD CUT OUTS ARE MADE IN THE INSULATION ONLY IN OUR FACTORY. THIS LEAVES THE WALL OF THE TANK EXPOSED READY FOR HOLES TO BE CUT ON SITE. (INSULATION CUT OUTS CAN BE PROVIDED IN SPECIFIC POSITIONS IF REQUIRED) PLEASE SUPPLY DRAWING OR SKETCH FOR DIMENSIONS.
- 6. STANDARD PLAIN AND PRE INSULATED TANKS ARE TO BE SITED INTERNALLY. IF YOU REQUIRE TANKS TO BE SITED EXTERNALLY PLEASE CONTACT US.
- 7. WE ADVISE THAT ALL OUR TANKS BE SITED ON A FLAT AND FULLY SUPPORTING BASE (IF YOU HAVE SPECIFIC BASE REQUIREMENTS PLEASE CONTACT OUR SALES OFFICE)
- 8. PRICE FOR OVERFLOW KITS IS SUPPLY ONLY. THE PRICES DO NOT INCLUDE FOR SUPPLY OR INSTALLATION OF ANY OTHER FITTINGS.
- 9. PRICES DO NOT INCLUDE FOR TESTING OR COMMISSIONING.
- 10. WHERE A BALL VALVE HOUSING IS REQUESTED A STANDARD HOUSING 780 x 600 x 330 mm INTERNAL DIMENSIONS IS QUOTED. THIS WILL INCREASE THE EXTERNAL TANK HEIGHT DIMENSION BY . 350mm
- 11. IF A TYPE A AIR GAP IS REQUIRED THIS CAN BE SUPPLIED IN TWO WAYS. A WEIR CUT IN THE SIDE OF THE TANK OR A BALL VALVE HOUSING WITH A WEIR CUT INTO THE SIDES. THESE CAN BOTH BE SUPPLIED WITH A PLAIN WEIR OR WITH THE WEIR COVERED WITH A STAINLESS STEEL MESH. PLEASE SPEAK TO OUR SALES OFFICE FOR MORE INFORMATION.
- 12. OFF LOADING IS CUSTOMERS RESPONSIBILITY.
- 13. ALL PRICES ARE EX WORKS UNLESS A CARRIAGE CHARGE HAS BEEN QUOTED.
